We presented her with an Arizona state flag that was flown over the state capitol building, in her honor, and more than 24 years of service to the state

- o Staffing Structure: On Monday, On May 2nd, we met with impacted staff and adjusted responsibilities. Licensing staff are no longer answering inbound phone calls and we have identified three specific staff/temps to serve as our customer service representatives who are solely responsible for answering those calls. By implementing this strategy, we intend to process licensing applications more timely and efficiently, thus eliminating a significant majority of phone calls. It was determined we need to have specific teams, Compliance, Licensing, Call Center, and Business.
- o Employee Engagement: during the month of April, all state employees were asked to complete an Employee Engagement survey.
- o State Employee Appreciation Day: agency team will be conducting a water drive to support the Phoenix Heat Relief program. All water will be donated to the downtown Human Services Campus.
