5. Update regarding on Professional Credential Services (PCS) Examination including the Written Practical Exam Via Computer-Based Testing (CBT) and updated Contract.

Interim Executive Director Irma Telles-Stewart stated effective April 1, 2022, Virtual, Inc will begin providing the written practical exam via Computer Based Testing (CBT) in partnership with National Interstate Council of State Boards of Cosmetology (NIC) approved vendor in lieu of the existing hands-on practical exam for the Cosmetology, Aesthetician, and Nail Technician profession. Virtual will continue to administer a hands-on practical exam for the hairstylist and Instructor professions at this time until CBT exams for these professions are made available. All fees will remain the same. Also, when the foreign languages are developed and made available, Professional Credential Services (PCS) will offer the written practical exams in Spanish, Vietnamese, and Korean.

Interim Executive Director Irma Telles-Stewart stated that Professional Credential Services (PCS) is working with the agency to include Barber's for Computer Based Testing (CBT).

Mrs. Mona Baskin, Assistant Attorney General stated HB2029 amended A.R.S. § 32-514(A), by permitting an individual to test prior to graduation. However, the individual needs to complete their courses and graduate.
