# IX. Review, Discussion, and Possible Action regarding the 2025 Barbering & Cosmetology Board Meeting Schedule.

Brandon McFadden & Tracy Wilkinson speak on the matter stating that Friday is a hard day to attend for the professional members.



Trista Guzman Glover states that Monday-Thursday would be difficult for her.

Brandon McFadden states that as a professional member with 100% attendance, Friday is a hard business day to miss and that any other day would be better during the week. Mr.McFadden states that if the professional members sacrifice to be there, they think other members should also.

Marshall Knox states that Friday is a hard day for the professional industry to meet and states they are not asking for every meeting to be moved but suggest maybe once a quarter so that it is not always on Friday.

Brandy Flores states that she believes Friday is the best day to have the meeting, that the Board Meeting should not shift days by month, and that it needs to be consistent.

Board Chair Gary Begley believes that staff should put together a document with all of the information compiled for them to review and vote at the next meeting.

Tracy Wilkinson states she understands it is a difficult day for the board staff and other members, but it would be better for the licensees who have to appear so they do not have to miss work if it is on a Monday.

Trista Guzman Glover asks if there have been any Quorum issues. Frank Migali responds by saying that in June 2022, we did not have a Quorum, and then in February 2024, we lost Quorum.

Marshall Knox speaks about how he has asked in the past, and it has always been shut down. He feels like all he hears today is being told no. He would like the board to try to have the meeting another day.

Board Staff will compile information from the discussion today and send out a Google form to all Board Members to get their feedback and availability to add to the agenda for board discussion next month.
